



# Strengthening Measles and Rubella Surveillance and Response Capacity through FETP Resident Training on Data Management and Outbreak Investigation

# **Objectives**

The project aims to:

- 1. Strengthen the country's capacity to manage and respond to measles and rubella outbreaks.
- 2. Strengthen the capacity of FETP residents in data management and outbreak investigation of measles and rubella.

## **BENEFICIARIES**

The activity will directly benefit Ministries of Health, national and subnational surveillance teams, laboratory personnel, FETP residents and graduates and Rapid Response Teams (RRTs) deployed for outbreak response. Indirectly, children, adolescents, and adult populations in priority countries will benefit from improved surveillance, and timely outbreak response, These efforts also safeguard regional health security by preventing cross-border

#### PROJECT PHASES

Phase 1 – Identify priority countries

Phase 2 – Develop a training curriculum and training materials

Phase 3 – Conduct a TOT at the national level

Phase 4 – Conduct one subnational cascade training

## PROJECT DESCRIPTION

EMPHNET conducted a comprehensive desk review of countries experiencing measles and rubella outbreaks to better understand the context in the Eastern Mediterranean Region (EMR). The review analyzed data from 2023, 2024, and up to June 2025, including incidence rates of measles and rubella, the status of rubella vaccine introduction (whether already implemented or in the process), vaccine coverage rates, and the functionality of national surveillance systems. Surveillance assessment considered reporting timeliness and completeness, as well as sensitivity, measured through the non-measles, non-rubella discard rate. Information was collected from multiple sources, including World Health Organization (WHO) bulletins and weekly updates, official websites of MoH in EMR countries, and relevant National Public Health Institutes responsible for surveillance.

Following a desk review and discussions with the CDC, four preliminary countries were identified: Lebanon, Morocco, Sudan and Mauritania. These countries were selected based on recent measles outbreaks and suboptimal vaccination coverage.

Based on these discussions, the proposed project (outlined under the project phases) aims to strengthen the capacity of the targeted countries in data management and in responding to measles and rubella outbreaks. The project activities include the development of a training curriculum and materials focused on data management and outbreak investigation, followed by a five-day Training of Trainers (TOT) at the national level and a subsequent five-day subnational training.

Additionally, EMPHNET will engage with the identified countries to gauge their interest in participating in the initiative and to assess their needs and priorities within the scope of the proposed project. The training modality (number of training days, mentors, and target participants) may vary based on each country's context and needs

The training targets FETP mentors, residents, and graduates affiliated with the Ministries of Health in the three identified countries (Sudan, Morocco, Lebanon and Mauritania).

# Currently ...

Preparatory discussions with CDC are ongoing to finalize the activity scope and agree on the four priority countries.

Additionally, EMPHNET is in the process of coordinating calls with the preliminary identified countries to gauge their interest and identify their priorities within the scope of the aforementioned activity.

# What is next . . .

EMPHNET, in collaboration with the CDC will finalize the concept note regarding this activity, which will lay the foundation for the implementation of the activity.

Following that, EMPHNET will strengthen its communication, coordination, and collaboration with the identified countries to determine priority training topics and initiate the development of the training curriculum and materials, allowing sufficient time for the implementation of the Training of Trainers (TOT) workshops and the country-led cascade training.

## **OUTCOMES BY NUMBERS**

EMPHNET, in collaboration with the CDC, will support **four priority countries** in strengthening their ability to respond to measles and rubella outbreaks, as well as enhancing their national surveillance systems for these diseases. This will be achieved by building the capacity of FETP residents and other relevant Ministry of Health staff, including Rapid Response Teams (RRTs).

Measurable Impact (in numbers):

- Strengthened measles and rubella outbreak response and surveillance systems in four countries.
- 20 trainees per country (totaling 80 trainers) competent in measles and rubella outbreak investigation and data management.
- 30 trainees at the subnational level per country (totaling 120 trainees) competent in measles and rubella outbreak investigation and data management skills and practices.
